CALL FOR ADDITIONAL CONTRIBUTIONS FOR INTERNATIONAL MOBILITY *for Bachelor, Masters and post-graduate students*

a.y. 2021/22

Collegio Universitario di Torino Renato Einaudi (hereinafter 'Collegio') announces, for the year 2021, **€ 19,000** for **contributions to supplement the international mobility** grant granted by the Universities of Turin to students who go abroad for a period of study / internship / research for the academic year 2021/22 in the context of:

- programs promoted by the European Union;
- even non-EU programs;
- bi-national degree courses;
- agreements between teachers / departments for short research / study periods not included in the programs referred to in the previous points (only for students enrolled in post-graduate courses).

For bachelor's and master's degree students, the period spent abroad must be recognized in terms of credits, as part of their course of study attended in Italy, even if for the purpose of the test conclusive.

The tendered amount is made up of:

- **€ 10.000** thanks to donations received with the **5x1000 year 2020** (income 2019);
- **€ 5.000** thanks to the **bequest in memory of Ermanno Borio**;
- **€ 4.000** as a **contribution from Collegio**.

The total amount is broken down as follows:

Recipients

The recipients of the contribution are the students of Collegio, holders of a study place for the academic year 2021/22, which:



are enrolled in a degree course at the Polytechnic of Turin, the University of Turin, the Turin State Conservatory of Music, the Institute of Applied Art and Design (IAAD), the European Institute of Design (IED), the Albertina Academy of Fine Arts in Turin, the Holden School of Turin, the Vittoria School for Linguistic Mediators in Turin;



are enrolled in post-graduate courses (2nd level masters, advanced courses and specialization schools or research doctorates).

Students who have already benefited from the mobility grants paid by Collegio twice in previous years are positioned at the bottom of the ranking.

The following cannot apply:

- students winners of the same contributions paid by EDISU Piemonte for the year 2021;
- students exempted by convention from the obligation to sign the Personalized Training Project (PPF).

Amounts

The contribution consists of **€ 200 per month**. The number of months paid depends on the length of stay abroad of the winners, up to a maximum of 10 months. The stay must be certified by the University / Institution that promotes the program and by any other structures directly involved in the program itself.

The disbursements will take place until the funds are exhausted: therefore, situations of assignment of contributions for a number of months less than the duration of the stay abroad may occur.

Method of participation

Candidates must by and **no later than 19 November 2021:**

- fill in the online form available at the link <https://forms.gle/yRZELU1HrqsY5i2h7>;
- send by ticket on the Student Portal (object: "International Mobility Notice 2021"), the

certification of acceptance of the study period abroad issued by the University of origin or destination.

Rankings

Grants will be assigned according to three rankings:

- 1. mobility projects lasting up to 6 months;**
- 2. mobility projects lasting more than 6 months;**
- 3. mobility projects for students enrolled in post-graduate courses** (2nd level masters, advanced courses and specialization schools or research doctor-ates).

The rankings **1)** and **2)** will be drawn up on the basis of the following criteria:

- Seniority of Collegio;
- In case of a tie: lowest ISEE indicator;
- In case of a tie: drawing of lots.

The ranking 3) will be drawn up on the basis of **the date of submission of the application** and the contributions will be equally distributed among the participants.

The provisional rankings will be published **by 3 December 2021**: applicants will be able to submit any observations via a ticket on the Student Portal.

The final rankings will be published **on 10 December 2021**. After the publication of the final rankings it will no longer be possible to make changes and / or take into consideration any reports received.

The list of winners / winners of the grants disbursed by the Collegio will be sent to EDISU Piemonte to verify that they are not also assignees of mobility grants provided by the Regional Body for the Right to University Education of Piedmont.

In case of grants not assigned in one of the rankings due to lack of candidates, the remaining contributions will be assigned to the other rankings with priority for the ranking for mobility projects of up to 6 months duration.

Terms of payment

The contributions will be disbursed in a single solution, **by the end of February 2022**, by bank transfer to a current account in the name or joint name of the winner.

Any additional costs relating to payment operations (eg: foreign bank transfer) will be borne by the winner / winner.

Following the publication of the rankings, the winners must communicate their bank details by filling in or updating the IBAN area of the Student Portal.

Obligations and penalties

- At the end of the mobility period, the winners are required to send **the return sheet** via ticket on the Student Portal;
- **In the event of supervening impossibility to carry out the period of study abroad** for the minimum duration, the student is required to promptly notify and possibly return what has already been received, in order to allow the re-assignment of the contribution;
- **In case of early return**, the student will lose the right to the monthly payments referring to the period of non-stay and will be required to return the amount re-ceived and no longer due. By monthly payment we mean a stay of at least 15 days;
- Any extension of the international mobility period granted by the universities will not be taken into consideration for the purpose of a re-determination of the amount, which will remain that indicated in the final ranking;
- **Winners referred to in this announcement, who sign during the academic year 2021/22 a hospitality contract with the Collegio, they will be called to return in full the contributions received if they do not fulfill - as established by the so-called PFP Regulations in force - their educational debt regarding PFP .**
