Chapter 1 - Application

1.1 Object and recipients

The **COLLEGIO UNIVERSITARIO DI TORINO RENATO EINAUDI (di seguito 'Collegio')**, Foundation ex art. 14 ss. c.c. registered in the Register of Legal Persons at the Prefecture of Turin and private institution without profit goals, and merit-based University Collegio recognized and accredited within the meaning of the DD.MM. nn. 672 and 673 – 2016,

**announces a contest for the confirmation of the accommodation benefit
for the a.y. 2021/2022**



specifically for the period
August 31, 2021 - July 31, 2022 included
excluding the winter holidays¹

This call is reserved exclusively for **students that already own an accommodation benefit in Collegio for the academic year 2020/2021.**

Specifically:

- **Students that are going to enrol to the 2nd (or above) year of a university course of a first level bachelor degree (L1), or master degree (LM) or single cycle degree program (CU)** that were admitted in previous years following the admission process stipulated by the Collegio;
- **Students admitted following specific agreements** between the Collegio and partner institutions (SSST, CCA, INPS, etc.);
- **Post-graduate students**, admitted by following the specific call for admission (POL);
- **Students with a EU/extra EU citizenship**, admitted by following the specific call for admissions (INT)

The provided services that characterize the Collegio experience are:



Residential services: the accommodation benefits offered in the Sezioni of the Collegio are described in the [Guida ai Servizi](#), on the official Collegio website that will be updated by June 30, 2021;



Personal training activities: multi-disciplinary training courses aimed to strengthen transversal skills, useful to complete the course of study and to assist the student to enter the world of work;

It is possible to request **a change of the Residence Hall** during the application process: as stated in the “Regolamento” for the Owners of an accommodation benefit, 1/3 of the available spots in each Residence Hall will be reserved to the relocation of the students who request it, with an eventual ranking that will consider the proximity of the new Residence Hall to the University site of the interested party, the alternative criteria will concern the number of years already spent in Collegio and then the academic merit for the confirmation of the accommodation.

The Collegio reserves the right to change the originally assigned room and Residence Hall, even after signing the housing agreement, and for objective reasons.

1.3 Requirements

The accommodation benefits will be confirmed for the a.y. 2021/2022 to the students that possess the requirements stated in the following table, concerning their specific category.

Concerning the **1st point of the table**, in accordance with the D.M. 673 of September 08, 2016, art. 4, 1.V, the students must have attended **the minimum number of hours of the Personal Training Program (PFP), and filled the questionnaires where available**. These are intended to evaluate the acquired soft skills as regulated in the “Disciplinare PFP”.

Concerning the **3rd point of the table**, no rounding is made: hence if the weighted average is below 24/30 the merit criteria for the confirmation of the allocation are not met if the number of CFU exceeded the one deemed necessary (see further CFU tables for each year's limit) the weighted average will include only the best single credits necessary to reach the minimum number.

The exams that are not graded with an explicit final mark – such as language exams and those that are only recognised as passed/not passed – and the exams not concerning the chosen university course curriculum, are not computable as part of the credits necessary for the confirmation.

Other exams that are valued with the same system will be counted as part of the necessary CFU and will be conventionally considered marked with 25/30.

The CFU that concern single modules of bigger exams, if passed, can be considered in the total CFU count required for the confirmation, up to a maximum of one module, **ONLY** if the student submits a certificate that states date, mark, and credit number signed by the professor; this certificate must be uploaded by July 31 2021 on the Student Portal.

The requirements stated from point 1) to point 6) of the table above must be possessed too by:

- Students that will participate in mobility/internship programs abroad or in Italy in the a.y. 2021/2022
- Students that have participated in mobility/internship programs abroad or in Italy in the a.y. 2020/2021

1.3.1 Special cases

The students that fall into the following “special cases” must adhere to these instructions.

1.4 Confirmation outcomes

Chapter 2 - Confirmation of the accommodation

2.1 Acceptance of the accommodation and required documents

After the publication of the confirmation outcomes, the students will have to:

Carry out the **payment of the 1st instalment** and security deposit following the stated methods

Sign the housing agreement and the “Allegato A” (Attachment A) that will be available in the HISTORY & RECEIPTS area of the Student Portal and upload it in the OTHER DOCUMENTS area



BEFORE SEPTEMBER 25, 2021

Upload in the OTHER DOCUMENTS area of the Student Portal a certificate or a **self-certification**, in accordance with the D.P.R. 445/2000, **signed and scanned that states the exams passed up until July 31st 2021**, in case the previously submitted document was incomplete.



BEFORE SEPTEMBER 30, 2021

Free the designated common rooms of any personal belonging left in Collegio in boxes, to render available these areas for educational purposes.



BEFORE NOVEMBER 15, 2021

Upload in the OTHER DOCUMENTS area of the Student Portal a certificate or a self-certification, in accordance with the D.P.R. 445/2000, signed and scanned that states the **regular enrolment for the year 2021/2022**. The students that are not obliged to enrol to the a.y. 2021/2022 to obtain the degree due to some University norms, must upload a self-certification that states the commitment to submit the enrolment certificate in case they did not graduate in the declared date.

Upload (within 30 days) in the OTHER DOCUMENTS area of the Student Portal a certificate or a self-certification, that includes all the exams passed, and a certificate of enrolment to a master degree – **ONLY FOR THE STUDENTS THAT GRADUATE FROM A BACHELOR DEGREE.**

Upload in the OTHER DOCUMENTS area of the Student Portal a certificate or a self-certification, in accordance with the D.P.R. 445/2000, signed and scanned that includes all the exams passed – **ONLY FOR THE STUDENTS THAT GRADUATE FROM A MASTER DEGREE OR A SINGLE CYCLE DEGREE PROGRAM.**

If these conditions were not respected, the student will lose the accommodation benefit.

The Collegio can request in any moment the access to the original paper documents.

2.2 Special needs students

Following the security norms, the participation to this call from special needs students must be accompanied by the required sanitary documents, which must be submitted using the Student Portal platform. The Collegio will perform arbitrary checks – with the eventual specialized medical visit – the condition of self-sufficiency related to the common areas. Given that this Call for Confirmation only concerns single room accommodations, it is not possible to house eventual carers. At the end of the application period, the students with disabilities will be contacted for an interview.

2.3 Annual fee and contribution brackets

The annual fee for the academic year 2021/2022 is € 7.000,00: of this amount, the part that consists of the student's contribution is calculated on the basis of the declared university ISEE (from January 2021); Collegio covers the remaining part.

The student's household is composed by the registry family at the moment of the DSU (Dichiarazione Sostitutiva Unica) submission, which must be presented to obtain the ISEE Declaration.

The students that will not submit a university ISEE declaration by the deadline of July 31st 2021 will be automatically assigned to the maximum contribution bracket (the 7th)

The following table shows the student's contribution of the annual fee for the a.y. 2021/2022:

The students that got their bachelor degree in the 4th year of 1st level university course, and that in the a.y. 2021/2022 will enrol to the 7th year since the first registration to the university, will be automatically assigned to the VII contribution bracket if in the a.y. 2020/2021 they were assigned from the I to the VI bracket, and to the VII if in the a.y. 2020/2021 they were assigned to the VII bracket. Hence, they will not be required to submit any ISEE document.

In case of allocation, during the a.y. 2021/2022, of an accommodation benefit to sibling(s) of a student that already resides in Collegio, the student can ask to take advantage of the 10% discount on the annual fee via ticket on the Student Portal.

This reduction will be applied as follows:

- On every instalment for allocation until October 2021;
- On the 2nd and 3rd instalment for allocations until February 2022;
- On the 3rd instalment for allocations after February 2022;

2.3.1 Special cases

INDEPENDENT STUDENT

The student's parents, even if they do not live at the same address, are still required to be part of the same household of the candidate, with the exception of legal divorce and/or separation, or the occurrence of both the following conditions:

- the candidate must have had residence outside the house of the rest of the family for at least 2 years before the submission to this call, in a place not owned by other family members;
- the candidate must have an adequate income capacity for the years 2019 and 2020, not below the amount of € 6.500,00 as declared or assimilated in 2019 and 2020 as well as any other tax-free income.

CURRENT ISEE

Whereas the income was significantly altered⁵ it is possible to declare a currently valid ISEE at the moment of the submission to this call or during the academic year, to update the income data of a DSU linked to an ISEE.

The students' contribution will be calculated on the basis of the current ISEE for the annual fee (a.y. 2021/2022) and for the successive instalments.

2.3.2 Students' contribution payment methods

The students' contribution will be divided into instalments in accordance with the following table:

The methods of payment (PagoPA or others) will be communicated to the student around the deadline for each instalment.

If the student fails to pay the 1st instalment before the deadline, **their submission will be considered invalid as they will not be eligible for the accommodation**, and the security deposit will be retained by the Collegio.

The students winner of the INPS benefit concerning the "INPS Collegi Universitari" call must pay the 1st instalment following the fees and the deadlines stated in the table above. The annual contribution will be re-calculated after receiving confirmation from INPS regarding the grant of the benefit, in accordance to the "INPS Collegi Universitari" call, and the Collegio will proceed with the necessary refund or adjustment of the exceeding of the 1st instalment.

2.3.3 Arrears for late payments

In case of late payment of the 2nd and 3rd instalments (or of a part of them), arrears will be applied as stated in the following table:

The methods of payment will be included in the request for the payment of the arrear. In case of pending payment, the Collegio will retain the sum from the student's security deposit.

The amount collected by the Collegio from the arrears of the a.y. 2021/2022 will be destined to institutional activities carried out by the Foundation in the year 2022.

2.4 Housing agreement

The legal relationship between Collegio Universitario di Torino Renato Einaudi and each student is regulated by a housing agreement, according to the art. 13 co. 5 of the D.L. 68/2012.

2.5 Personal Training Program and “Diploma di Collegio”

Each student must sign a Personal Training Project (PFP) for the academic year spent in Collegio, as stated in the D.M. 673 of September 8, 2016, art. 4, 1.V. The choice of said formative activities and the agreement to the PFP for the a.y. 2021/2022 is simultaneous to the signing of the housing agreement, as stated in the previous point of this call.

The PFP aims to give an integrative, transversal, and interdisciplinary training, which has the purpose of educating conscious adults, with a particular focus on the greater good.

Every student must choose their own training plan within the Annual Training Plan (PFA) prepared by the Collegio and by the Section Directors. As per the aforementioned DM, the minimum hours a student is required to attend each academic year is: 70 if the student is enrolled in the 1st, 2nd, or 3rd year of university, 25 if the student is enrolled in the 4th year or above. At the end of the permanence period, each student will receive the Diploma di Collegio, which certifies the acquired skills.

2.6 Permanent check-out by the end of the academic year

2.6.1 Early check-out

Following the admission and the housing agreement, the student can still renounce the accommodation and permanently check-out from the Collegio before the end of the academic year. This withdrawal must be communicated by filling the specific form. It can be found on the platform Student Portal and the deadlines are specified in [chap. 2.6.2](#). Communications sent via e-mails or any other mean will not be taken into consideration.

2.6.2 Partial refund on the paid student contribution

In case of early withdrawal of the housing agreement, refunds will be applied as stated in the following table:

No refunds will be applied (unless the accommodation is awarded to another student, so it is possible to be refunded accordingly to the months benefitted by the new owner)

For those students that will obtain the confirmation of the accommodation benefit, and that desire to check-out in September before officially entering in Collegio: the withdrawal of the housing agreement and the refund payment will follow the norms concerning permanent check-out before September 30, 2021.

The previously illustrated refunds will NOT be paid whether the student that opted for the early check-out did not successfully complete the minimum limit of training hours (PFP) that are required in the relative permanence period.

If the Section in which the student resides were to be object of ordinary or extra-ordinary maintenance work, the student will not be eligible for refunds of the fee – neither partial nor total – and/or financial compensations.

2.6.3 Security deposit return

The deposit return will be carried out by the end of the following month of the check-out span, on the condition that the permanent check-out form (that can be found on the platform Student Portal) is filled following the deadlines specified in [chap. 2.6.2](#).

The Collegio will proceed **to retain the deposit** in the cases referred to in the housing agreement and in the following cases:

- the student did not complete the Personal Training Program (PFP) as required by their respective disciplinary plan;
- the terms and deadlines of this admission procedure were not respected;
- the student did not communicate by the terms and modalities stated in [chap. 2.7](#) the willingness to temporarily check-out and the relative suspension of the accommodation;
- the student did not communicate by the terms and modalities stated in [chap. 2.6.2](#) the willingness to permanently check-out.

If any type of damage to the furniture and/or to the room itself was to be registered during check-out, these will be quantified and the resulting sum will be retained from the security deposit.

2.7 Mobility and absences from Collegio

Chapter 3 - Partner Institutions

3.1 INPS benefits for children and orphans of employees and pensionates of the Public Administration

If the agreement between INPS and the Conferenza dei Collegi Universitari di Merito (CCUM, www.collegiuniversitari.it/it/index.aspx) and/or the Collegio was renewed, the students interested to obtain the confirmation of the accommodation in Collegio within the meaning of this agreement must submit their confirmation application by submitting to this call, and simultaneously participate to the “INPS Collegi Universitari” call, available on www.inps.it. These students must possess the requirements necessary to participate to both the INPS and the Collegio admission processes.

If they will be confirmed following what stated in this call and in in the “INPS Collegi Universitari” call these students will have to pay the relative contribution and they will benefit from the services envisaged by the agreement.

The students winner of the INPS benefit concerning the “INPS Collegi Universitari” call must pay the 1st instalment following the fees and the deadlines stated in the table above ([chap 2.3.2](#)). The annual contribution will be re-calculated after receiving confirmation from INPS regarding the grant of the benefit, in accordance to the “INPS Collegi Universitari” call, and the Collegio will proceed with the necessary refund or adjustment of the exceeding of the 1st instalment.

In case the students lost or refused the INPS benefit, they can still obtain the accommodation confirmation by participating to this call, if they possess the necessary requirements. If they obtain the confirmation, the students will be subject to the dispositions stated in this call, including those at [chapter 2.3 Annual fee and contribution brackets](#). For the months not covered by the INPS benefit, the Collegio will calculate the student’s contribution on the basis of their University ISEE 2021, following this algorithm:

**(annual fee based on the contribution bracket / 11 months of permanence for the a.y.)
x n° months of permanence not covered by the INPS contract**

Moreover, they will be required to state the graduation date (LM or CU). It will be possible to remain in Collegio up to the winter holidays if they graduated by December 2021, and up until the summer closure if they graduated after January 1st, 2022

3.2 Partner Institutions

Each year, thanks to a deliberation signed by the “Board of Directors”, the Collegio reserves a certain number of accommodations rendered available for specific agreements stipulated with Institutions within the framework of higher university education, that aim to enhance the academic merit. These spots are assigned following the distinctive merit criteria stated by said Institutions in their own admission program.

As for the Scuola di Studi Superiori Ferdinando Rossi dell’Università degli Studi di Torino and the Collegio Carlo Alberto, the students that owned an accommodation in Collegio for at least 6 months during a.y. 2020/2021 will be able to obtain the confirmation of the accommodation only if they possess the necessary requirements and in the following cases:

- **If the rules of the Institution didn’t allow the permanence in Collegio for students in particular conditions such as the year in which they are supposed to graduate;** in this case the Collegio will allow them to submit to this Call for Confirmation outside the limits of the agreement; the students of the Collegio Carlo Alberto in this particular condition can submit their request even if they did not complete the minimum PFP hours, as they are exempt from it according to the agreement;
- **In case students were admitted to the Collegio with ordinary processes and only later became part of an agreement.** In this case, they are still required to finish the minimum Personal Training Program (PFP) hours as stated in co. 1.V. art 4 D.M. September 8, 2016, n. 673 and respect all the merit and participation criteria referred in this Call for Confirmation

In case of confirmation of the accommodation, these students will be subject to the disposition included in this call, including the [chapter 2.3 - Annual fee and contribution brackets](#).

Moreover, they will be required to communicate the date of graduation (master degree or single cycle degree program) and will be able to remain in Collegio up to the winter holidays if they graduated by December 2021 and up until the summer closure if they graduated after January 1st, 2022

Chapter 4 - Terms and conditions

With the submission of the application, the candidate declares to possess complete knowledge of the following documents for the entire period of permanence in the Collegio:

- The dispositions included in the ministerial decrees MIUR September 8 2016, nn. 672 e 673;
- The dispositions included in the Call for Confirmation for the a.y. 2021/2022; and to accept the obligations that these provisions involve concerning the position of student of the Collegio di Merito.

Moreover, the candidates declare, under their own responsibility:

- Of being aware of the civil and penal sanctions one is to be subjected to if they provided mendacious declarations, or if they created or used false documentation, as stated in art. 76 of the DPR n. 445

dated December 28, 2000;

- Of being aware that the personal data required for the aforementioned purposes are required for the correct development and management of the activities linked to the Foundation's goals and purposes. The candidate agrees to gain knowledge about the policy ex art. 13 of the Reg. 675/96 at the moment of the accreditation on the Student Portal, and to agree, where requested, to the treatment of personal data, in accordance with the [Privacy Policy](#)

Chapter 5 - Assessment of the truthfulness of the declaration

The Collegio will carry out checks on the provided declarations and will investigate on any dubious information with the means deemed necessary. Furthermore, it will ask for specific background checks and for intelligence to be handed over to the "Polizia Tributaria", the "Amministrazione Finanziaria dello Stato", the Municipalities, the Societies and "Uffici Catastali".

The candidate is to be excluded from the position and the benefits it includes in any moment, whether the provided declarations were found to be untrue. The false declarations are subject to punishments in accordance with the Codice Penale (Penal Code) and with the specific laws (art. 75 e 76 D.P.R. December 28 2000, n. 445).
