

## SPECIFIC FAQ FOR ADMISSIONS PROCESS

### ISEE/DSU

I have available an ISEE statement issued in 2023. Is it okay to submit it among the documents for admission, since my family's income has not changed?

Please note that in order to be considered valid, the ISEE Attestation: must be issued in 2024, must apply to the benefits for the right to university study for the student participating in the announcement (i.e. contain his/her FISCAL CODE), must not have discrepancies/omissions. For more information, contact a CAAF center or consult the INPS institutional website. It is not necessary to upload the DSU.

### MISSED ISEE BY JUNE 30

I miss to submit ISEE certification by the June 30 deadline. What happens?

Students who fail to submit the ISEE 2024 Certification by the deadline of the Call for Admission will be automatically placed in the maximum contribution bracket (Band VII).

### REPORT PAPERS AND DIPLOMA

Do I have to enter the grades on the report card individually?

No, you must enter the 3rd and 4th grade average separately, considering conduct, but without the religion grade.

I have applied for Admission to Collegio, but I still do not have the 5th year report card available. What should I do?

You can already upload the 3rd and 4th year report cards since, as required by the Call for Admission, we only consider those and the 5th year report card is not required.

I participated in the Call for Admission in Collegio and I have just obtained my High School Diploma. Where can I upload it?

It will not be necessary to provide a copy of the certificate of completion of the baccalaureate or bachelor's degree, however, the College reserves the right to conduct spot checks after the fact on students admitted to the Collegio.

## OUTDATED EXAM CERTIFICATE

I have taken one or more exams during the first appeals of the summer session, but I am waiting for their recognition to send the self-certification of exams required by the Notice of Admission to the Collegio. How can I do this?

You can already upload the available self-certification as we consider exams and credits taken by 15/03/2024.

## CALL PROCEDURE

I have entered the application on the portal and received the confirmation email. What do I need to do now?

You need to complete the self-assessment questionnaire (you received the link via email) and book the individual interview within 3 days.

## RENOUNCE APPLICATION FOR ADMISSION

I have applied for admission to the College, but I plan to withdraw my application. What should I do?

Open a ticket on the Student Portal indicating your intention to withdraw your application.

## INPS CALL FOR PROPOSALS

I was a winner of the INPS Call for Applications for University Colleges. What does the Collegio Admission work?

Even for those who participate in the INPS call for applications, it is still necessary to pass the Collegio selection. Therefore, there is no "fast track" for those who participate/win the INPS call for applications, but one always follows the ranking list and thus the sliding lists provided in the call for applications (Art. 1.4.2 Waiting lists and sliding criteria).

## SCROLLINGS OF WAITING LISTS

I am in the top positions in the waiting lists. When will the next scrolling take place?

As stated in the notice of admission (Art. 1.4.2 Waiting Lists and Sliding Criteria), we conduct rankings sliding as soon as new study places become available. You can check your position at any time in the RESULTS GRADUATORIE area of the student portal. We would like to

### **CONTRACT OF HOSPITALITY AND CHANGE OF REGISTERED RESIDENCE**

**I was admitted to the Collegio and signed the Hospitality Contract. Is it necessary to register it in order to then take up residence in the Collegio?**

Pursuant to Article 13 c.5 of DL 68/2012, "the relationship between the manager ("Collegio") and the user (student) is governed by a hospitality contract of a hotel nature. For this reason, it is not a lease of a residential property, but precisely a hospitality contract. The Notice of Admission and the hospitality contract do not allow guest students to make a change of registered residence at Collegio Einaudi.

### **FAMILY DOCTOR**

**I have been admitted to the Collegio. By when do I have to report my choice of primary care doctor in Turin?**

Within 30 days of admission to the Collegio, you must proceed to upload in the OTHER DOCUMENTS area of the Student Portal the receipt of acceptance of the application for the choice of primary care doctor in Turin.
